SRO Reynolds reported: Officer Reynolds & Mrs. Goodall collaborated with the Attorney General's Office to conduct a presentation on digital media safety to the JH & HS students. Deputy Mathew Marass with the Sangamon County Sheriff's Office will lead the Explorers Program. This program allows students to explore law enforcement. Officer Reynolds continues his daily activities and covers a wide range of tasks for purposes of maintaining the safety and well-being of the school.

Hogan reported: The 8th grade Boys' Basketball team will be recognized at tonight's board meeting for their accomplishments this season. HS Girls' Basketball season ended with a loss in the semi-finals of Regional playoffs. The co-op with Lutheran has had very positive feedback. HS Boys' Basketball started Regionals on February 19th. The JH Volleyball County Tournament began on February 17th and was hosted by Riverton. JH Regionals will be held at Mt. Olive with 7th grade starting February 24th and 8th grade starting March 2nd. The start date for HS Baseball is February 26th. The interest meeting for HS Softball was held on February 13th. The start date is February 26th. The co-op with Morrisonville and Lincolnwood for HS Track was approved. The start date was February 19th. The interest meeting for JH Track is scheduled for February 27th. The start date is March 11th. The TK embroidered patches have now been added to the Spring sports programs. Baseball will have the patch on the hats and stickers for the helmets. Softball will have the patch on the visors and stickers for the helmets. JH & HS Track will have the patch added to the long-sleeve warm-up tops. 8-man Football schedule was released in mid-January. Mrs. Hogan is close to publishing the schedule for next year. Mrs. Hogan is having difficulty getting games scheduled on Friday evenings. Officials are usually booked years in advance with 11-man teams, so it is difficult to book a Friday night 8-man game. Scheels has donated \$2,500 to the Bass Fishing program. The Concussion Committee will meet on March 28th. Pawnee will host the HS MSM Scholastic Bowl Meet on February 27th. 10 teams will compete.

Hennemann reported: the E-Learning data shows that 88% of students in K-6th participated. Pre-K had a dental event on February 9th. Pre-K has now filled all 54 spots. Pre-K screenings are scheduled for mid-May. IAR professional development training was held on February 9th for 3rd – 6th grade teachers. Mr. Hennemann is finishing up with teacher evaluations.

Goodall reported: IAR testing for JH will be held on March 18-20. ISA testing for 8th graders will be held on March 22nd. ISA testing for 11th graders will be held on April 23rd. SAT and PSAT testing is scheduled for April 17th. The Juniors will test at PHS due to internet requirements. Mrs. Goodall, Mrs. Hyde & Mrs. Polistina met with Jodie Ferriell who is the Director of ROCTE on January 18th. This meeting resulted in 3 more pathways within our Career and Technical Education Programming which will give us more access to ROCTE monies moving forward for classroom use. We added STEM, Environmental Science and Family & Consumer Science. Certified teacher evaluations have been completed. Non-certified evaluations will be addressed in March. Mrs. Hyde is currently working on scheduling for next year. The STEM and Farm To Table programs were featured twice by local media outlets. The Attorney General's Office put on a digital safety presentation on February 20th to our JH & HS students. CACC has been a wonderful addition to what we can offer to the students. In 2022-2023, we sent 14 students to CACC. This year, we sent 23 students to CACC. We are predicting 33 students to attend CACC in the 2024-2025 school year.
