The Foundation is strongly committed to increasing our efforts to support a scholarship program that meets the educational needs of our graduates.

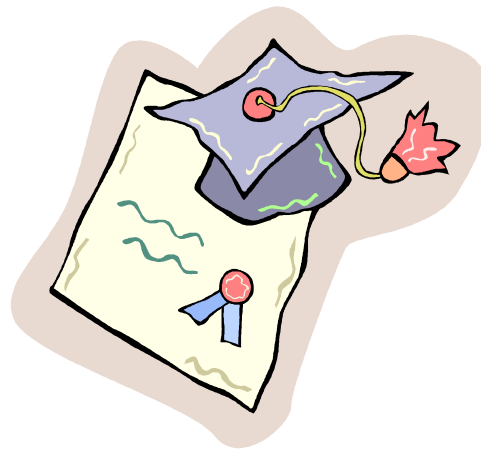
Our goal is to seek charitable gifts to provide the best scholarships for our students.

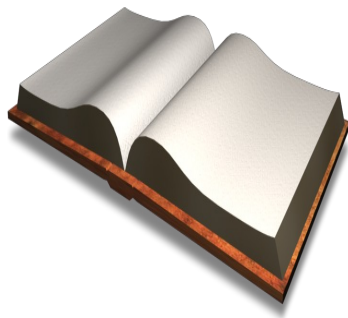

General Operating Fund

Gifts made to this fund will be used where the need is greatest as determined by the Foundation committee.

Scholarship Support

Gifts can be directed specifically for scholarship support and/or to students who have special financial need. These donations will be used exclusively for scholarships. The Foundation can assist in developing and determining guidelines for these types of contributions.

Planned Gift

These gifts can be made for any purpose and in any amount. Usually, a planned gift is much larger and is done through estate planning. These gifts may provide tax benefits and you should consult your tax advisor or attorney. These gifts may be made through provisions in one's will or trust and make it possible to provide a planned gift while one is still living through charitable remainder trusts or insurance.
