Superintendent Report

- Great News We have been back to in-person instruction now for two weeks. It has gone rather smoothly. I want to thank the staff, students and parents for making this work. We are looking at what the next steps can be for getting more instruction to the students. Preliminary numbers for the new stimulus package has come out. The district is expecting \$439,185. The administration is working on a plan for the funds.
- CTI will be completed with the fiber infrastructure by the board meeting. They plan to finish up on January 18th. We will now be ready for the next step. Bringing fiber into the building. We have RFP's out through E-rate at this time. Only one bid so far and it is from Comcast.
- Our Health Life Safety projects and building need estimates should be in. I will present those to the board. The board then can then let me know the direction that we would like to proceed. These projects would be paid through health life safety money and county facility sales tax money collected.
- I have only received two bids for the MFSAB (small bus). It is from Southern Bus and Mobility and Midwest Bus Sales. Southern Bus & Mobility has the state bid. Southern price is \$55,016 and Midwest is \$58,783. We have already received a donation of \$5,000 towards this purchase with another \$5,000 after purchase. I will need direction of what the board would like to do.
