- Thank You to Jill, Staci, Linda, and Mandy for getting information together for the auditors. The auditors were here for a few days and completed the audit.
- Summer work is being completed most of the classrooms and hallways have been waxed. Work is still being completed in some of the rooms. We are waiting on the titanium boards to be delivered. Things are going well, but the stretch run to compete all projects is beginning.
- Finance The ESSR III grants have been opened. We have plenty of time to get it completed. I will begin working on the grant shortly. Good news - the grant was released and we are receiving \$1,005,119. This is around \$30,000 more than anticipated.
- Curriculum School Wide Title Waivers have been completed and submitted. This has to be done before we can submit our Title Grant. The Title Grant will continue to be worked on and submitted as soon as possible.
