Mr. Hennemann reported: He thanked Chelsi and Mandy for all their hard work trying to open the school year; Summer School is finishing up and thanks to Mrs. Gehrs for running the reading program and to our teachers and paraprofessionals for their hard work; 39 students attended the reading program and 10 resource students attended the ESY program; teachers will meet face-to-face or via Zoom with each student and parents starting as early as August 24th and lasting through September 4th; the first week of full remote learning is to start the week of September 7th; Pre-k will be contacting families and doing home visits remotely starting the week of Monday, August 17th.

Mr. Kratochvil reported: JH is down 10 students and HS is down 6 students; students will have orientation next week; there will be two lists for orientation, student list 1 and student list 2; student list 1 will attend Monday, August 24 and Tuesday, August 25; student list 2 will attend Wednesday, August 26 and Thursday, August 27; we will run Block A and Block B days from 8:00 a.m. to 12:00 p.m.; Friday, August 28 will be for any students that may have missed orientation or needs an additional meeting with a teacher.

Mr. Cameron reported: He congratulated Scott Day, Jim Underwood and his crew on getting the building ready; He also thanked Mrs. Gehrs, Mr. Woodcock and Mrs. Ervin for helping Mr. Hagler get the Chromebooks set up; the buses and vans are almost completed with the updated security camera systems; the Title and Early Childhood grants have been submitted to the State and we are hopeful to have approval quickly; the School Board Convention has been cancelled for this year.





School Board Report

Superintendent Report

- Good News – I just want to congratulate Board Member Gary Starr for receiving the LeaderShop and/or Master Board Member Program recognition award. Congrats Gary. Congrats to the Village of Pawnee. Their fireworks show over the holiday weekend was great. Kudos to the softball team for getting the number one seed in regional's. Congrats to the boys baseball team for getting the 2nd seed in their regional's.
- We continue to work on getting the remote learning issues fixed. We have ran into some bumps in the road and some pot holes along the way. However, the staff has continued to work hard for our students.
- The task force team met on Tuesday, September 22nd. I plan on telling the board the direction the task force would like to pursue in returning to school. I know that I would like to see kids starting to come back.
- Our Title and Early Childhood Grants have been approved. We are still waiting on the second round of Federal Stimulus Package to be approved. Once approved we should be receiving more COVID dollars flowing our way. Just don't know an amount as of yet.
- The administrative team completed the new 3 hour Title IX training on September 15th. The training was lead by the district attorneys. A pdf version of the training will be listed on the district website. This is also a mandate.
- Just a reminder the Triple I (School Board Convention) has been cancelled for this year thanks to the COVID-19 pandemic. So no trip to Chicago this year.
