## **Good News:**

- At the beginning of the school year, the Chatham VFW, which also serves the Pawnee community, sponsored an essay contest. Mrs. Zeibert's 6<sup>th</sup> grade writing class participated. Trenton Hull won 1<sup>st</sup> place, and Drew Hisel was the 2<sup>nd</sup> place winner.
- Mrs. Zeibert was nominated and selected as the grade 6-8 Teacher of the Year! This, too, was sponsored by the Chatham VFW.
- We received confirmation that some of the additional preK funds written for last spring have been allotted to our district! The funds will be used to fill a Parent Coordinator/Instructional Leader position.
- Mrs. Melton and Ms. Grandchamp's classes set up a table during the PTO's Winter Carnival for the first time, and raised \$170! They will use this money for classroom activities.
- A huge thank you goes to Mrs. Chambers for the wonderful winter concerts! I have received compliments from both performances.
- Our staff collected \$437 for the Reese family.

# Administrative Report:

- No discipline to report.
- I have been working with the 5<sup>th</sup>/6<sup>th</sup> grade team to revamp our behavior system at those levels. We plan to begin implementation after winter break.
- November monthly assembly:
  - o Second graders performed a Native American dance.
  - o More than 30 students received incentives from the Gotcha drawing.
- Professional development:
  - o Mrs. Rogers and Mrs. McQuality presented some activities to use in the classroom after attending a workshop in November.
  - Ms. Mast, Mrs. Gulso, and Mrs. Guess attended a writing workshop and presented some of what they learned to the staff during our SIP day.

## • Curriculum update:

- Once we receive Title funds, we will purchase Fountas & Pinnell Classroom (FPC) materials for grades K-2, and part of grade 3. Full implementation will be expected during the 2018-19 school year at the K-2 levels. Professional development will be provided; I have been in touch with the curriculum director in the Sangamon Valley school district and will look into school visits to observe implementation there as well. This will expand into other grade levels over the course of the next year or two.
- Teachers have been looking at Step Up to Writing curriculum materials. This focuses on the more formal types of writing. So far, I have received positive input from grade level teachers. I believe Title funds would cover this for grades K-6 at this point.
- o I presented a Dave Ramsey curriculum to Mrs. Sitze for the 6<sup>th</sup> grade level; she is extremely interested in implementing it during the fourth quarter if possible.
- Our preschool monitoring visit for both programs occurred on November 15 and 16.
   Areas of non-compliance were in the expansion program due to the lack of a Parent Coordinator/Instructional Educator position.
  - O The additional funding that was recently approved will allow us to fill this position for the remainder of the 2017-18 school year. Chelsea McGlothlin will serve in this role.

### Grants

- o PFA and PFAE 5-year recomplete proposals are due January 12.
- A second round of changes was submitted for our Title grant on December 14.
   We hope to have funding approved soon.

- o 20/24 formal evaluations have been completed.
- o All informal observations (24) have been completed. (I informally observed tenured teachers once and nontenured teachers twice.)
- o 6/15 paraprofessional evaluations have been completed.
