7.1 Discussion and Possible Action Regarding the Sanitary Sewer Line Project - All costs are part of the Maintenance Grant, which we match. Throughout the discovery process, we determined that it was not necessary to remove or disturb the flooring near the media center. The estimated cost for plumbing, asphalt, concrete, and labor is approximately **\$140,000–\$145,000**, which remains within the available grant funding. The major discovery in the media center was a significant blockage that requires additional construction. The estimated cost for this work is **\$80,000–\$85,000**.
